**INSTRUCTIONS FOR COMPLETING DOG LICENSE  
APPLICATION/RENEWAL**

1. All dogs in the Town of Rossie must be licensed with the Town clerk by the age of four (4) months. A current rabies certificate is required at the time of licensing or the renewal of an existing license. All dog licenses will be for a period of one year and will expire at the end of the month, one year from the date of issue.  
*(Dog Control Law for the Town of Rossie – Local Law No. 1 of the year 2010)*
2. Rabies vaccination must be valid on the first day of the month after the current expiration date (if a license expires on April 20, 2024, in order to renew the license, the rabies vaccination must be valid on May 1, 2024).
3. For validation of this license, submit in person or by mail with required documentation and renewal fee to the Rossie Town Clerk, 908 County Route 3, Redwood, NY 13679. A validated license will be sent to you.
